**NOTICE IS HEREBY GIVEN** that pursuant to a resolution of the Board of Fire Commissioners, a public hearing will be hosted by the East Fishkill Fire District in the Town of East Fishkill, County of Dutchess, State of New York, and will be held at the East Fishkill Fire District Headquarters, located at 2502 State Route 52, Hopewell Junction, New York, on the 17<sup>th</sup> day of October, 2017, at 7pm to take public comment on whether the Fire District Board of Fire Commissioners should approve the following resolution:

**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE EAST FISHKILL FIRE DISTRICT, TOWN OF EAST FISHKILL, COUNTY OF DUTCHESS, STATE OF NEW YORK (THE “DISTRICT”), AUTHORIZING THE CREATION OF A TAX ZONE WITHIN THE FIRE DISTRICT FOR THE PRIMARY PURPOSE OF FUNDING THE PURCHASE, MAINTENANCE AND OPERATION OF APPARATUS AND EQUIPMENT FOR PROTECTION OF LARGE COMMERCIAL STRUCTURES WITHIN THE TAX ZONE.**
